Elections For Board Of Directors

Attention Innovations Annual Members! Innovations will hold elections for Board of Directors this November 4th, 2006. The positions up for election: Vice President and Treasurer. The general election guidelines are provided for in the club Bylaws. (A copy of the Bylaws is always available.) The following is a brief description of the election timeline:

- August: The current Board of Directors appointed a Nominations Committee: Carol Schwartz and Martha Peleti.

The Committee is responsible for seeking and/or accepting all nominations for any of the offices up for election. Any parties interested in running for office must contact one of the committee members. In addition to answering any questions about the offices and the election they will make up the official ballot.

- **September 30th, 2006:** Nominations are closed. Candidates names and pictures will be published in the club's November newsletter.
- **October 7th, 2006:** Outgoing Board members, current Board members and candidates for office will be presented at the Anniversary Party.
- **November 4th – Election Day!:** All members are invited to vote and attend a **brief** general membership meeting at Starlight Dance Studio at 9 PM. The order of business will be:

Starting at 6 PM - Annual Members will be checked-in on a special attendance roster and a ballot issued to each attendee. Members will fill out the ballots and place them in a ballot box. At 9 PM voting is officially over and the ballots will be counted by the Ballot Committee.

9 PM - President's State-of-the-Club address, Treasurer's Report, Membership Report.

10 PM or when ballots have been counted – Announcement of new Board of Directors.

Vice President and Treasurer Duties

Vice President:

- Assist the President and other members of the Board of Directors in the performance of their duties.
- Assume the office of President in the event that office is officially or temporarily vacated.
- Negotiate with workshop instructors.
- Be authorized to sign on Club bank accounts.

Treasurer:

- Maintain a financial accounting system adequate to the needs of the Club and consistent with generally acceptable accounting procedures.
- Be accountable for the management and control of all Club funds.
- Prepare written financial reports to be circulated at regular Board meetings and when specifically requested by the Board.
- Present an Annual Financial Report at the Annual Membership Meeting.
- Arrange, as necessary, for a financial audit of the Club's financial records, by a financial professional(s) approved by the Board.
- Be responsible for ensuring all necessary filings and reports required by Federal and State agencies are prepared in a timely manner.
- Ensure that all checks issued bear the signatures of 2 Board members.
- Serve as President in the absence of the President, Vice President and Secretary.
- Be a signatory on all Club bank accounts and ensure only directors holding an elected officer position act as signatory on Club bank accounts.
